

Please take some time to go through the Rules and Regulations mentioned below and SIGN on the next page. SIGNATURE is also required on Registration Form. Please fill up the same and submit / send to us at our office.

**Bookings:**

- Flycatcher Adventures is a division of Palande Tourism.
- Flycatcher Adventures reserves all rights of admission for ecotours (wildlife camp / trekking programme / any other programme announced by Flycatcher Adventures.)
- Booking for all tours will be done on first come first served basis.
- Bookings for tours are to be made at the office of Flycatcher Adventures.
- Flycatcher Adventures reserve all rights to change the venue / dates / schedule / cost or cancel the tour.

**Charges & Expenses:**

- The participants shall, along with the booking form, pay prescribed booking / advance amounts.
- **Balance payments (if any) shall be paid at least 30 days before the tour departure date.** If the balance payment is not made within stipulated one week, then the registration shall be deemed to be cancelled; cancellation charges as per cancellation rules will be applicable.
- Any incidental / additional expenses incurred during the camps / ecotours shall be borne by the participants.

**On Camp Regulations:**

- During the tour, the participants shall abide by the instructions and decisions of the Camp Director or authorised representative of Flycatcher Adventures.
- During the tour or camps, in case of any dispute for whatsoever reasons, the decision of the Camp Director or authorised representative of Flycatcher Adventures shall be final and binding on all the participants. In the event the participants disobey the directions / instructions of the Camp Director or authorised representative of Flycatcher Adventures, the participant(s) shall be solely liable for the risks, responsibilities and consequences.
- In case of any medical ailments, disorders etc. of the participants, they will have to inform the organisers in advance at the time of booking for the tour.
- In case of any medical problems, ailments, disorders etc. or symptoms of the same, during the tour, the participant(s) shall inform the organisers at the earliest.
- In such events, if required, the participants will have to take medical treatment from the doctor/ attendant available on the campsite or from the nearest available medical centre or hospital. The expenses for all medical treatment and arrangements for the same will be solely borne by the participant. The Camp Director or the authorised representative shall have complete discretion to continue the camp without the participant(s) suffering from medical problem.
- Any incidental / additional expenses incurred during the tour shall be borne by the participants, this include expenses for food during travel by any mode of transportation, camera or like equipment charges, entry charges etc.
- Consumption and/or possession of liquor, tobacco products, cigarette, Narcotic substances etc. is strictly prohibited on tour / Camp / trek / other programmes organised by Flycatcher Adventures.

- In case of any injury, sickness, accident, death or any other casualty or loss or damage of valuables or luggage or any equipment; Flycatcher Adventures, its instructors, organisers, volunteers or any other person involved wholly or partially, either individually or jointly, shall not be responsible in any manner for the same and no claims of the participants, parents, guardians, relatives or friends of participants will be entertained.
- If the participants have enrolled for the activities like wildlife camping, river rafting, rappelling, rock climbing, valley crossing, river crossing or any other adventure sports / activity, then all the risks and responsibilities related to and arising from such activities shall be solely upon such participants and Flycatcher Adventures shall not be liable in any manner whatsoever.
- It is not possible for Flycatcher Adventures to ensure that the Group / Participants will get Railway Reservations (reserved for Participants on their behalf) together or in the same compartment because of random seat allotment by Computerised Railway Reservation System.
- **Insurance:**  
Neither participants nor tours shall be insured by Flycatcher Adventures, unless mentioned specifically.

**Cancellation Policy and Refund Rules:**

- Any cancellation by participant(s) must be communicated to Flycatcher Adventures in Office in writing in the prescribed format available at Flycatcher Adventures office. The refund, if any, will be given after the tour is over, irrespective of the date when the cancellation has been communicated to us.
- **Cancellation charges structure:**
  - 80% refund (of amount paid) if the cancellation is made with more than 30 days (excluding the day of departure of tour) remaining for camp departure date.
  - 30 % of the regular camp charges will be charged if the cancellation is made more than 15 days (excluding the day of departure of ecotour) prior to the departure date of the camp.
  - 70 % of the regular camp charges will be charged if the cancellation is made more than 7 days (excluding the day of departure of ecotour) prior to the departure date of the camp.
  - No refund if the cancellation is made with 7 or less than 7 days (excluding the day of departure of ecotour) remaining for camp departure date.
  - **In case the participant(s) have booked air tickets / railway tickets / bus tickets or hired a taxi in for the tour (or its extension), through us, then the refund paid by the airline authorities / railway authorities / bus operator / taxi operator shall be forwarded to the participants after deducting the processing charges, in case of cancellation made for the tour by the participant or tour being cancelled by Flycatcher Adventures.**
  - Flycatcher Adventures shall not be responsible for losses incurred for the air / train / bus bookings, or any extension to the tour camp, done by the clients, either independently or through us arising due to cancellation in the ecotour by Flycatcher Adventures. In such cases, only the Amount accepted as tour Charges will be refunded.
- Flycatcher Adventures reserve all rights to change or modify the tour / camp programme. Management reserves all rights to prepone or postpone the tour and Flycatcher Adventures shall not be liable to refund booking charges in such a case.

- Flycatcher Adventures reserves all rights to cancel any tour / camp. In that event, 'refund amount' after deducting 'non-refundable costs' (such as Forest safari booking charges, Railway reservation and cancellation charges, Travel arrangements booking charges, Accommodation booking charges) will be refunded within 15 days from date of cancellation of such an tour.
- Safety Cancellation: Flycatcher Adventures is in no way obligated to complete a tour if one or more participants is found to be endangering the safety of themselves, others or the environment. Refunds will not be given in this situation.
- In the event there is cancellation of tour / camp due to force majeure / reasons beyond control of Flycatcher Adventures, then no refund shall be payable.
- Disputes, if any, will be subject to Pune Jurisdiction only.
